

Pet Boarding and Grooming Agreement

THIS PET BOARDING AGREEMENT (this "Agreement") is made and entered into by and between DIAMOND C PUPPY CLUB, LLC, a Limited Liability Company in the State of Texas, and the person identified as the "Pet Parent," herein below. The parties herein agree to the following:

I.

Services

DIAMOND C PUPPY CLUB provides pet boarding, day boarding, and grooming services. Pet Parent hereby engages DIAMOND C PUPPY CLUB to provide the services for his or her pet(s) as set forth on the website, the information sheet provided to the Pet Parent, the terms and conditions set forth in this Agreement by DIAMOND C PUPPY CLUB.

II.

Payment

Pet Parent agrees to pay all fees for boarding, day boarding, veterinary care or other services owed on the day of pick up. Prices are subject to change without notice and season rates may apply. Boarding rates as of the date of this Agreement are as follows:

- Small Dogs (0-20 lbs) \$25.00/day
- Medium Dogs (21-70 lbs) \$35.00/day
- Large Dogs (71+ lbs) \$45.00/day

Each additional dog in the same run is \$20.00/day

III.

Health and Vaccinations

Pet Parent represents to DIAMOND C PUPPY CLUB that, to the Pet Parent's knowledge, pet has not been exposed to any contagious diseases within a thirty (30) day period prior to check-in. DIAMOND C PUPPY CLUB reserves the right to refuse a pet at check-in for any reason including without limitation, a pet that appears sick, injured, in pain, or exhibiting behavior that could jeopardize the health or safety of other pets or our staff.

Pet Parent acknowledges that pet is current on all vaccinations as requested by DIAMOND C PUPPY CLUB. Pet Parent agrees to provide documents confirming such vaccinations as requested by DIAMOND C PUPPY CLUB. Pet Parent understands that all pets at DIAMOND C PUPPY CLUB are fully vaccinated however, it is still possible for your pet to become ill. Pet Parent understands that this is not due to any circumstances or condition at DIAMOND C PUPPY CLUB and agrees to hold DIAMOND C PUPPY CLUB harmless in the event a pet becomes ill during or after their stay.

If at any time a pet is found to have fleas or ticks, DIAMOND C PUPPY CLUB may provide the appropriate flea or tick removal treatment, at the expense of the Pet Parent.

IV.

Emergency Medical Treatment

Pet Parent acknowledges that, in the unlikely event the pet becomes ill or injured, or if pet has a pre-existing condition that becomes aggravated by its stay and requires professional attention, we will attempt to notify Pet Parent or the Emergency Contact listed herein at the phone numbers provided.
